In this document, 'Ski Organisations' means the Whistler Nordics Ski Club (WNSC), Cross Country British Columbia (CCBC) and Cross Country Canada (CCC), and their directors, officers, employees, agents, members, and volunteers. 'Sanctioned Activities' means activities organized by the Whistler Nordics Ski Club, and identified as such in club publications and on its website. They include, but are not restricted to, recreational cross-country skiing, competitive cross-country skiing, training for cross-country skiing, and related recreational, sporting, and social activities.

DISCLOSURE & ASSUMPTION OF RISK

XC skiing, training, competitions, and related activities, including Sanctioned Activities, are dangerous, and may injure or kill you. Hazards include:

- > Frostbite, hypothermia, and hyperthermia.
> Poor weather, including cold, wind, fog, snow and rain.
> Falls on hard and icy surfaces, collisions with trees, machinery, people and other hazards.
> Unmarked environmental hazards, including poorly groomed and ungroomed ski runs.
> Backcountry hazards, including cliffs and avalanches.
> Joint, ligament and cartilage injuries, fractures, and other musculo-skeletal damage.
> Lack of or inadequate training, skill, fitness, clothing or equipment.
> Heart attacks, strokes, and other cardio-pulmonary events.
> Driving to and from events in poor conditions.
> Other members / skiers who behave in a negligent or unsafe manner, including skiers who ski excessively fast or in an uncontrolled manner, in light of conditions, terrain, and their skill.
> Activities that are largely or entirely organized by volunteers.
> The other hazards normally considered integral to these activities.

RELEASE & WAIVER OF LIABILITY
